# **Dog Requirements**

- 6-5-2a: Any dog over the age of 4 months that is owned, harbored, kept, or sheltered within the City shall at all times be vaccinated against Rabies. Proof must be produced to any authorized agent of the Animal Care and Control Division.
- 6-5-1a: No person shall own, harbor, keep, or shelter a dog more than 4 months of age without purchasing a license for the dog
