Block Parties Bring People Together

Annually, hundreds of Rosedale Park neighbors gather for block parties to celebrate, eat, drink, play games and generally have a good time. It's a tradition that goes back 30-40 years, and it continues today. Yes, Detroit is on the rebound and our neighborhood is a classic example of people coming together to share food and stories, and generally allow the kids to have the best time they can.





Excessive Noise Disturbs Neighbors

The Rosedale Park Code Enforcement Committee has recently received several complaints from residents about excessive noise created by nearby residents who are holding parties and using amplified music to add to the festive atmosphere. Dogs that bark all night or for extended periods of time are also causing sleepless nights for those who live nearby.

BARKING DOGS

While the Code Enforcement Committee actually loves dogs, residents who own dogs are advised that they are responsible for the behavior of their animals at all times and that constant barking is inappropriate for our residential area. Dogs that bark constantly can be declared a public nuisance and their owners held responsible. Some dogs that bark constantly do so if they are left outside too long, not attended to for long periods of time, and sometimes just because they tend to be nervous. All those issues can be helped by the owner and sometimes by discussions with their vet.

PARTY MUSIC

The Code Enforcement Committee appreciates that music is an essential part of any party. However, neighbors who hold parties are reminded to keep the volume down to a reasonable level so as to respect the rights of their neighbors to NOT be disturbed in the peace and quiet in their homes. Just because you want to party doesn't mean everybody around you should be forced to party along with you.

Chapter 36 of the Detroit Municipal Code spells out that it is:

"unlawful for any person to unreasonably disturb the public peace and quiet, or to unreasonably disturb or annoy the quiet, comfort and repose of persons in the vicinity by shouting or whistling, by loud, boisterous, or vulgar conduct, or by the playing of a compact disc player, musical instrument, phonograph, radio, tape player, television, videotape machine, or any other device, equipment, or instrument that amplifies, produces, or reproduces sound, in any public or private place."

There are additional restrictions specifically concerning speakers:

"It is unlawful to maintain or operate an outdoor speaker that is affixed to any structure or placed upon any property where:

- (1) The speaker is audible for a distance of more than fifty (50) feet from the source; or
- (2) The speaker is two hundred fifty (250) feet or closer to a location that is zoned or developed for residential use."

A person who violates these provisions is guilty of a misdemeanor and can be fined up to \$500 and/or sentenced up to 90 days in jail.

So, this is not meant to tell you that the Police will come to your door, although that has happened. It's meant instead to remind you that we are a neighborhood made up of many neighbors and we always want to be kind and generous in our actions towards our neighbors. That makes good neighbors and good neighborhoods.

So, whether it's barking dogs or party music, let's keep the volume down – it's the neighborly thing to do.

RPIA Bylaws Revision

The RPIA Bylaws were last revised in 2011. Since then some operations have changed, just as the timing of RPIA's fiscal year, and the addition or adjustment of Board Committees. The proposed revisions reflect these changes, and have been edited for consistent vocabulary and capitalization, etc.

There are 1622 households in Rosedale Park. As of August 8, only 423 households (26%) have paid their 2014 dues. It's time for the other 1199 households to pay their share.

Dues payments support the costs of publishing this newsletter, the cost of snow removal from our City streets this coming winter, the cost of our June Day picnic, the Easter Egg Hunt, and the annual Holiday Pancake Breakfast.

Please pay your share – only \$45 for the year (residents of Outer Drive and Evergreen pay \$25, since Wayne County and the City of Detroit remove the snow from those two streets). If your container is damaged beyond repair, the cost to replace it is \$20. But almost all of the time, repairs are possible, so give them a call if you need this service.

It will include the paper shredder, along with the regular items of paper, cardboard, Styrofoam, metals, plastics, plastic bags and batteries. off Pierson north of Grand River.
